WPWMA Tour Policy, Assumption of Risk/Liability Release Agreement

I, the undersigned, hereby acknowledge that I have voluntarily signed up to participate in a tour of the WPWMA facility, which may include:

1. The Materials Recovery Facility (MRF) is an industrial facility that processes solid waste including green waste. The MRF can be loud, dirty, dusty, and odoriferous. Numerous trucks and other vehicles, machinery and heavy equipment are present and may be encountered while touring this portion of the facility.
2. The Western Regional Sanitary Landfill is an active landfill operation disposing of solid waste. Like a grading operation, heavy equipment with limited visibility are present and may be encountered while touring the facility.
3. The Household Hazardous Waste Collection Facility receives, processes and packages for shipment, certain types of potentially hazardous materials collected in the MRF or brought to the facility by waste haulers and customers. Trained handlers transport these materials to a covered area for sorting and bulking.

Tour Policy

1. There is a limit of ten (10) attendees per tour guide. If there are more than ten in a group, individuals will be split into multiple tours at the discretion of the WPWMA.
2. Closed-toed shoes **MUST** be worn by ALL participants during the tour, no exceptions. Any participant wearing open-toed shoes will not be allowed on the tour and will be asked to wait in the WPWMA's administrative building room until the tour is concluded.
3. At this time, only visitors over the age of 16 are allowed to tour the facility on public tours. There must be at least one (1) adult for every five (5) children.
4. The tour is conducted inside and out and consists of walking and climbing stairs. Appropriate clothing for the weather is suggested. An elevator is available at the MRF for tour participants who require one, but arrangements must be made in advance to accommodate this request.
5. There are eddy current separators (strong magnets) in the MRF which could interfere with pacemakers and/or other electronic equipment. If you have a pacemaker, please notify WPWMA staff at the beginning of the tour. It is highly recommended that visitors with pacemakers **DO NOT** leave the catwalk during the MRF tour.
6. Failure to follow this policy may result in immediate removal from the facility and/or not being allowed to participate in future tours.

Photo Release

Photographs may be taken as part of the WPWMA’s educational outreach program. I give to the WPWMA, its nominees, agents, and assigns unlimited permission to use, publish, and republish in any medium including print, the internet, or broadcast, for the purposes of promotion and description of WPWMA services, written information and reproductions of my photographic likeness with or without identification of me by name.

Assumption of Risk/Liability Release Agreement

I acknowledge that I willingly and voluntarily assume all risk of harm, including bodily injury, death or property damage as a result of participation in this activity or of my use of **WPWMA** facilities during the activity, and hereby waive all claims against **WPWMA**, its contractors, employees, agents, officers and all other persons as a result.

Due to the potential dangers of participating in this activity, I (or for any minor on whose behalf I am signing this release) recognize the importance of following instructions regarding proper technique, training and other established site safety rules, guidelines and regulations. I agree to abide by all rules and regulations during the activity.

Furthermore, should I require medical treatment during the activity, I give **WPWMA** agents, employees, and associates express permission to arrange the requisite medical treatment.

I agree that the terms of this release shall serve as a release of any and all legal liability, and as an assumption of risk for myself, my personal representatives, heirs, next of kin, spouse, members of my family, assigns and all other persons.
